Student Motor Vehicle Regulations

1. Only motor vehicles approved through this application process (“approved vehicles”) may be parked on school property.
2. Approved student drivers must possess at all times a valid driver’s license and vehicle registration.
3. Students will not transport any other passengers unless proper permits are obtained and approved.
4. The issued parking permit must be displayed at all times when the vehicle is on school property.
5. Students must park in designated areas without obstructing other vehicles, building exits or fire lanes. Improperly parked vehicles may be towed, and students may lose their parking privileges and be subject to disciplinary action under the Code of Conduct.
6. School buses have the right of way on school grounds at all times.
7. Student behavior regarding vehicle use should not create a disturbance. For example, radios, stereos and other sound systems are not to be audible outside of the vehicle.
8. Students are to come promptly to and from their vehicles at the beginning and end of each school day. No loitering is permitted in or around vehicles at any time.
9. Students will comply with all state and local Vehicle and Traffic Regulations and drive in a safe and courteous manner.
10. Driving to school is a privilege and not a right. Students who choose to apply and park vehicles on school property understand and consent that:
 - a. the vehicle will be subject to periodic canine sniffs for contraband; and
 - b. the vehicle can be searched upon reasonable suspicion that it contains contraband or evidence of violation of law and/or District policy and regulations, including the Student Code of Conduct.
